AN ORDINANCE OF THE TOWNSHIP OF KISKIMINETAS,
ARMSTRONG COUNTY, PENNSYLVANIA, VACATING A
PORTION OF TOWNSHIP ROAD NO. 460 AND MAKING
IT A PRIVATE ROAD, THE SAME BEING WITHIN THE
BOUNDRY LIMITS OF SAID TOWNSHIP

The Board of Supervisors of Kiskiminetas Township,
Armstrong County, Pennsylvania, under the authority of
"The Second Class Township Code" of the Laws of the Common-
wealth of Pennsylvania, Act of May 1, 1933 P. L. 103, as
amended, does enact and ordain as follows:

Section 1. All that part or portion of Township Road
No. 460, starting at the intersection of Township Roads No.
464 and 460, thence in a Southeast direction for a distance
of 0.60 of a mile shall be and the same is hereby vacated.

Section 2. All of the part or portion of Township
Road No. 460, as above described and vacated, shall be a
private road.
