Order of Court
approving vacation.

And now, Sept. 29, 1951, it appearing from the record of the proceedings of the Board of Supervisors of Kiskiminetas Township, Armstrong County, Penn'a., as filed at the above number and term of said court as stated, that the said Board of Supervisors, acting in accordance with the provisions of the Act of Assembly of 1933, P.L. 103, as amended by the Act of 1947, P.L. 1461, and further amended by the Act of 1949, P.L. 819, (No. 216), Sec. 1102 et sequor, has vacated a part or portion of a township road in said Kiskiminetas Township, known as T-548, extending from a township road in Yound Township, Indiana County., Pa., (now vacated) in a northwesterly direction to a township road in Kiskiminetas Township known as No. T-339, a distance of approximately 2857 feet; and further, that, on August 22, 1951, a full record of the proceedings of said Board of Supervisors was filed at the above number and sessions of said court; and further, that a period of more than thirty (30) days has elapsed since the filing of said proceedings, and that no objections to said vacation proceedings have been filed, nor have any claims for damages arising from said vacation been made or filed which would require the appointment of a Board of Viewers to hear and pass upon the same;

Therefore, the court does now order and decree that the action of the Board of Supervisors of Kiskiminetas Township vacating a part or portion of said Township Road No. T-548, as in said proceedings particularly mentioned and described, is ratified, approved and confirmed; and the appointment of a Board of Viewers, heretofore inadvertantly made, is now revoked.
