

Approving and adopting the survey, laying out and opening of the roadways, streets and alley, described by metes and bounds, in the Knepshield and Patterson Plans of Lots in the Township of Kiskiminetas, as township roads in the system of highways of the Township of Kiskiminetas, Armstrong County, Pennsylvania, without petition of abutting property owners.

Section 1. BE IT ORDAINED AND ENACTED by the Supervisors of the Township of Kiskiminetas, County of Armstrong, Pennsylvania, upon public hearing, in the judgment of the Supervisors, said roads are necessary for public convenience, and are hereby approved and adopted as Township Roads. The said roadways, described by metes and bounds, are as follows:

A certain unnamed road or street in the J.M. Patterson Plan of Lots, as laid out by L.G. Anderson, Registered Engineer, on August 27, 1938, said Plan of Lots being recorded in Armstrong County Plan Book, Volume 2, page 4, described as follows:

BEGINNING at the intersection of the unnamed road or street to be taken over with Township Road No. 385, thence along the unnamed road or street to be taken over in a Southerly direction 633 feet to the line where lands formerly of J.H. Wright, now D. R. Beers, and lands formerly of Henry Smith, now Eugene Barclay, join.

The said unnamed road or street being 30 feet in width.

Sections of certain roads or streets and an alley in the J.I. Knepshield Plan of Lots, as laid out by L.G. Anderson, Registered Engineer, on April 5, 1937, recorded in Armstrong County Plan Book, Volume 1, page 113, described as follows:

BEGINNING at the intersection of Township Road No. 385 with California Avenue at the Northern boundary of said Plan; thence

along California Avenue in a Southerly direction 474.2 feet to the intersection of a 15 foot unnamed alley; thence along the said 15 foot unnamed alley in an Easterly direction 327.48 feet to the intersection of Florida Avenue; thence along Florida Avenue in a Northerly direction 499.0 feet to the intersection of Township Road No. 385.

Both sections of the said roads or streets being 30 feet in width; the section of the unnamed alley being 15 feet in width.

Section 2. This Ordinance enacted pursuant to the powers conferred by the Act of July 20, 1953, P.L. 511, or its amendments.

Section 3. All ordinances, or parts of ordinances inconsistent herewith are hereby repealed.
