

ORDINANCE NO. 1-68

An Ordinance signifying the intention of the Township of Kiskiminetas, Armstrong County, Pennsylvania, to organize a municipal authority under the Act of May 2, 1945, P. L. 382, as amended, to be known as "Kiskiminetas Township Municipal Authority" for the purpose of undertaking such projects as authorized or permitted by the Municipality Authorities Act and as the Township of Kiskiminetas may, from time to time, authorize and specify.

The Board of Supervisors of the Township of Kiskiminetas hereby enacts and ordains as follows:

Section 1. The Township of Kiskiminetas hereby signifies its intention to organize an authority under the Municipality Authorities Act approved May 2, 1945, P. L. 382, as amended.

Section 2. The President and the Secretary of the Board of Supervisors are hereby authorized and directed to execute on behalf of the Township of Kiskiminetas, Articles of Incorporation for said Authority in substantially the following form:

ARTICLES OF INCORPORATION

To the Secretary of the Commonwealth, Commonwealth of Pennsylvania:

In compliance with the requirements of the Act of May 2, 1945, P. L. 382, as amended, the Board of Supervisors of the Township of

Kiskiminetas, County of Armstrong, Commonwealth of Pennsylvania, desiring to organize an Authority under the provisions thereof, does hereby certify:

1. The name of the Authority is "Kiskiminetas Township Municipal Authority".

2. The said Authority is formed under the Act of May 2, 1945, P. L. 382, as amended and supplemented.

3. No other Authority organized under the said Act of May 2, 1945, as amended, or by any other Act of Assembly on authorizing and regulating municipal authorities, is in existence in or for the incorporating municipality, the Township of Kiskiminetas, County of Armstrong, Commonwealth of Pennsylvania.

4. The name of the incorporating municipality is the Township of Kiskiminetas, and the names and addresses of its municipal authorities are as follows:

Ray J. Patterson, Star Route, Apollo, Pennsylvania, Supervisor, Secy.

5. The names, addresses and terms of office of the first members of the Board of said Authority are as follows:

Meridith E. Liebl, Star Route, Apollo, Pennsylvania - 5 years  
Richard T. Casella, R. D. 3, Apollo, Pennsylvania - 4 years  
William L. Hileman, R. D. 3, Apollo, Pennsylvania - 3 years  
Miles G. Reefer, Star Route, Apollo, Pennsylvania - 2 years  
William C. Nelson, Star Route, Apollo, Pennsylvania - 1 year

6. The project or projects to be undertaken by said Authority shall be projects permitted and authorized by the laws of the Common-

wealth of Pennsylvania as the Board of Supervisors of the Township of Kiskiminetas may from time to time by Resolution or Ordinance specify.
