

## ORDINANCE NO. 1-2004

---

**THE TOWNSHIP OF KISKIMINETAS HEREBY SIGNIFIES ITS INTENTION TO ORGANIZE AN AUTHORITY UNDER THE MUNICIPALITY AUTHORITIES ACT APPROVED JUNE 19, 2001, P.L. 287 No. 22, AS AMENDED, 56 P.S. §5601 et seq.**

Section 1: The President and the Secretary of the Board of Supervisors are hereby authorized and directed to execute on behalf of the Township of Kiskiminetas, Articles of Incorporation for said Authority in substantially the following form:

### ARTICLES OF INCORPORATION

In compliance with the requirements of the Act of June 19, 2001, P.L. 287, No. 22, as amended, the Board of Supervisors of the Township of Kiskiminetas, County of Armstrong, Commonwealth of Pennsylvania, desiring to organize an Authority under the provisions thereof, does hereby certify:

- A. The name of Authority is "Apollo Area Community Pool and Regional Recreation Authority".
- B. The name of the Authority is formed under the Act of June 19, 2001, P.L. 287, No. 22 as amended, 53 P.S. §5601 et. seq.
- C. No other authority organized under the said Act of June 19, 2001, as amended, or by any other Act of Assembly on authorizing and regulating municipal authorities, is in existence in or for the incorporating municipality, the Township of Kiskiminetas, County of Armstrong, Commonwealth of Pennsylvania.


- F. The project or projects to be undertaken by said Authority shall be:

Acquiring, holding, constructing, improving, maintaining and operating, owning and leasing either in the capacity of lessor or lessee, land, buildings, and a pool which shall be available for use by all persons regardless of race, color, creed, or national origin, subject to the payment of appropriate fees to be determined by the Authority.
  - ii. Such other projects as the Township of Kiskiminetas may from time to time by resolution specify.
- G. A public hearing, as required by the Municipality Authorities Act, was held on the 14<sup>th</sup> day of April, 2004.
