

ORDINANCE No. 2 - 1966

An Ordinance to lay out, widen and open certain roads wholly within Kiskiminetas Township, Armstrong County:

WHEREAS, all of a majority in interest of the owners of property or properties have petitioned, or in the judgment of the Supervisors, as the case may be, have decided, in the interest of public convenience, to lay out, widen and open, by ordinance, certain roads wholly within the Township, now therefore,

BE IT ORDAINED AND ENACTED by the Supervisors of Kiskiminetas Township, and it is hereby ordained and enacted,

Section 1. That pursuant to the petitions aforesaid, or, in the judgment of the Supervisors, the following described roads be and the same are laid out, widened and opened.

(a) The following street or roads in the Shellhammer Plan known as Orchards Hills, as recorded in Armstrong County Plan Book volume 2, Page 279; part of South Avenue, Cross Street and Ohio Avenue, each being thirty-three (33) feet in width, described as follows:

South Avenue and Ohio Avenue. BEGINNING at a point on South Avenue at the present west paving line of township road Route No. 486, also known in Lot Plan as Florida Avenue, thence by South Avenue North 77 degrees 00 minutes West 380.0 feet; thence by same N. 53 degrees 00 minutes W. 290.0 feet; thence by same N. 51 degrees 00 minutes W. 230.0 feet; thence by Ohio Avenue N. 20 degrees 27 minutes E. 885.0 feet, more or less, to the South paving line of State Highway Route No. 03097.

Cross Street. BEGINNING at the proposed south paving line of South Avenue, thence S. 6 degrees 00 minutes West 386.0 feet to the north property line of Lot No. 5 in the said Plan of Lots.

(b) A forty (40) foot wide road commonly known as the G. I. Road and the American

Legion Road and being the road in the W. W. Dickey Plan of Lots, which road intersects Township Road No. 460 approximately 870 feet South of State Route No. 56 and said road runs from Township Road No. 460 in an easterly direction for a distance of 1,494.58 feet.

(c) A forty (40) foot wide road, commonly known as the Shaeffer Road beginning at the north side of State Route No. 03-097 and intersecting the same and said road runs from State Route No. 03-097 in a northerly direction for a distance of 675 feet.

(d) A forty (40) foot wide street or road commonly known as Talmadge Avenue in the McKinstry Hill Plan of Lots, said road beginning at the east paving line of Township Road No. 536 and intersecting the same and said road runs from Township Route No. 536 in an easterly direction for a distance of 700 feet.

(e) The following fifty (50) foot wide streets or roads in the Miller Plan of Lots in the Village of Spring Church, as recorded in Armstrong County Plan Book Volume 2, Page 151.

ALL of Fourth Street and part of Fifth Street from the east side of Clark Avenue to the eastern end of Fifth Street.

(f) The following streets or roads in the Warren Heights Plan of Lots as recorded in Armstrong County Plan Book Volume 3, Pages 26 and 27.

ALL of Summitt Avenue being a fifty (50) foot wide street from Old State Route No. 56 to Highland Avenue in said Plan, and a forty (40) foot wide street from Highland Avenue to relocated State Route No. 56.

Part of Highland Avenue from Summit Avenue to Lincoln Avenue in said Plan, being a fifty (50) foot wide street or road.

Section 2. That in the judgment of the Supervisors the above roads are necessary for the public convenience and the Township Solicitor is authorized and directed to file a certified copy of the ordinance in the office of the Clerk of Quarter Sessions of Armstrong County, together with the release of damages signed by the abutting property owners, where necessary, and a draft or survey of each road.
