

ORDINANCE NO. 6-53

Of the Board of Supervisors of Kiskiminetas Township, Armstrong County, Pennsylvania, taking over, appropriating and adopting as public highways in said Township, certain streets and alleys (or portions thereof) in Plan of Lots known as "Grandview" and "Owenview Home Sites," and other traveled highways adjacent thereto, the same being now within the limits of said Township.

The Board of Supervisors of Kiskiminetas Township, Pennsylvania, lawfully assembled do ordain and adopt as follows:

WHEREAS, there are within the limits of the said Township certain Plan of Lots known as "Grandview" and Owenview Home Sites", the same being of record in the office of the Recorder of Deed of Armstrong County in Plan Book, Volume 1, page 151, and Plan Book, Volume 1, page 258;

AND, WHEREAS, there was formerly a public highway leading from State Highway No. 03120 to State Highway No. 56, which has been abandoned by the State Highway Department, but is available for public travel;

AND, WHEREAS, the Board of Supervisors of said Kiskiminetas Township believe it would be advantageous to the traveling public and to owners of real estate in the said Township that certain streets and alleys (or parts thereof) named or designated on said Plan of Lots above mentioned be taken over and maintained as

highways of the Township;

THEREFORE, the Board of Supervisors of Kiskiminetas Township do hereby adopt, take over and assume jurisdiction over certain streets and alleys (or parts thereof) designated in said Plans of Lots above mentioned and referred to, as highways of and in said Township, and to be maintained as much, the same being more particularly designated as follows:

1. Isabella Avenue, thirty-five (35) feet in width, from its intersection with Kenwood Street, thence in a southerly direction for an approximate distance of 775 feet to the property line of Riverview Cemetery.

2. An unnamed alley, fifteen (15) feet in width, midway between Isabella Avenue and Highland Avenue, extending from Kenwood Street in a southerly direction for an approximate distance of 775 feet to the property line of Riverview Cemetery.

3. Kenwood Street, thirty-five (35) feet in width, from its intersection with Isabella Avenue, thence in an easterly direction for an approximate distance of 232 feet, to its intersection with Highland Avenue.

4. An unnamed alley, fifteen (15) feet in width, from its intersection with Kenwood Street (opposite Isabella Avenue), thence in a northerly direction for a distance of approximately 133 feet.

5. Highland Avenue, fifty (50) feet in width, from the line where Highland Avenue joins Warren Avenue at the dividing line between the Borough of Apollo and the Township of Kiskiminetas, thence in a south easterly direction for a distance of approximately 305 feet thence in a southerly direction for a distance of approximately 787 feet to the line of property of Riverview Cemetery.

6. Rose Street, thirty-five (35) feet in width, from its intersection with Highland Avenue, thence in an easterly and southeasterly direction, for an approximate distance of 1958 feet to its intersection with Owensview Avenue.

7. Owensview Avenue, thirty-five (35) feet in width, from its intersection with Rose Street, thence in a northeasterly direction for a distance of approximately 650 feet to its intersection with State Highway Route 03120.

8. A road, approximately thirty (30) feet in width, not presently designated by name, extending in a northeasterly direction from State Highway No. 03120 for a distance of 1400 feet, more or less, to its intersection with the present State Highway Route No. 56.

9. An unnamed alley, ten (10) feet in width, extending from the intersection with Isabella Avenue in an easterly direction for a distance of approximately 232 feet to its intersection with Highland Avenue.
