ORDINANCE NO. 6-73

AN ORDINANCE OF THE TOWNSHIP OF KISKIMINETAS AUTHORIZING THE EXECUTION AND DELIVERY OF A SERVICE AGREEMENT BETWEEN KISKI VALLEY WATER POLLUTION CONTROL AUTHORITY AND THE TOWNSHIP OF KISKIMINETAS AND OTHERS COVERING A SEWAGE DISPOSAL SYSTEM TO SERVE CERTAIN AREAS OF THE TOWNSHIP, AND AUTHORIZING THE EXECUTION AND FILING OF AN APPROVAL REQUEST AND DEBT STATEMENT FOR SAID SERVICE AGREEMENT WITH THE PENNSYLVANIA DEPARTMENT OF COMMUNITY AFFAIRS AND IN THE RECORDER OF DEEDS OFFICE IN ARMSTRONG COUNTY.

WHEREAS, the Township of Kiskiminetas has empowered and directed Kiski Valley Water Pollution Control Authority to finance and construct a sanitary sewage transportation and treatment system in accordance with the plans and specifications and reports of The Chester Engineers, Inc., of Coraopolis, Pennsylvania, the Authority's Consulting Engineers, to serve those certain areas of the Township designated in said plans and specifications and reports; and

WHEREAS, in order for the Authority to finance said construction it is necessary for the Township and others to enter into a Service Agreement with the Authority; and

WHEREAS, in order to render said Service Agreement effective as to the Township, it is necessary, pursuant to the provisions of the Local Government Unit Debt Act, to provide for the adoption, execution and filing of an "Application for Approval," including a "Debt Statement", a "Borrowing Base Certificate", and a "Self-Liquidating Debt Exclusion Certificate", with the Pennsylvania Department of Community Affairs, and upon the receipt of the approval thereof, to file a copy of the same in the Recorder of Deeds Office in Armstrong County.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of the Township of Kiskiminetas, and it is hereby ordained and enacted by authority of the same as follows:

agreement with Kiski Valley Water Pollution Control Authority, substantially in the form of the Service Agreement presented to this meeting, dated as of July 1, 1973, which is hereby made a part hereof by reference only and is on file with the Township Secretary.

SECTION 2. The Chairman of the Board of Supervisors is hereby directed to execute, on behalf of the Township, the service agreement substantially in the form of the said Service Agreement, which Service Agreement when consummated shall be attested to by the Township, shall be delivered to the other parties thereto, and shall, after proper filings and approvals, be excluded self-liquidating lease rental debt of the Township.

SECTION 3. The Chairman of the Board of Supervisors and the Township are hereby further directed to prepare, execute and verify under oath a "Debt Statement" and a "Self-Liquidating Debt Exclusion Certificate" of the Township in order to make effective the aforementioned Service Agreement, and to submit the same, together with an "Application for Approval" of said Service Agreement and the necessary filing fee, to the Pennsylvania Department of Community Affairs pursuant to the Local Government Unit Debt Act, as promptly as practicable. Upon approval by the Pennsylvania Department of Community Affairs, the approved "Self-Liquidating Debt Exclusion Certificate" shall be promptly filed by the aforementioned officers of the Township in the Recorder of Deeds Office in Armstrong County in order to perfect such exclusion in accordance with Section 206 of the Local Government Unit Debt Act. Said officers are also hereby authorized and directed to perform all other acts and do all other things necessary to perfect such exclusion.

SECTION 4. The Board of Supervisors hereby further authorizes and directs that Kiski Valley Water Pollution Control Authority shall undertake the acquisition and construction of its proposed Initial Construction Project for its Sewage Disposal System in accordance with the plans and specifications prepared by The Chester

and pursuant to the terms of the Trust Indenture, dated as of July 1, 1973, with National Bank of the Commonwealth, as Trustee, and as secured by the Service Agreement approved hereunder.

SECTION 5. All ordinances or resolutions or parts of ordinances or resolutions not in accord with this Ordinance are hereby repealed insofar as they affect this Ordinance.

SECTION 6. This Ordinance shall take effect ten (10) days after its final enactment.
