RESOLUTION 7-2021

WHEREAS, the Kiskiminetas Township board of Supervisors held a public hearing on January 13, 2021 to amend the fee structure of Ordinance 2-90; and,

WHEREAS, it is necessary to increase certain fees in order to carry out certain provisions of the ordinance; and,

NOW THEREFORE, the Kiskiminetas Township Zoning Ordinance, to wit, 2-89 is amended to read as follows:

Article II: the following fee schedule is adopted for use by the Zoning officer and the Zoning hearing board:

| f. Application for a plan group unit-(plus engineer fee)                 | \$100.00/per acre  |

| h. Application for a sign permit-  | \$25.00            |

| i. Application for zoning occupancy permit-   | \$25.00   |
| j. Application for a hearing before the Zoning Hearing Board for any reason. In the event that it is determined that the total costs exceed \$800.00, the Zoning officer will provide the applicant an itemized Statement and the balance due will be within 20 days of final decision. Note; this fee is payable whether approved or denied. | \$800.00/plus extra fees incurred by Township, if any |
| k. Copy of zoning ordinance-  | \$.25 per page/\$45.00 max                            |
| l. Pool-with pool deck included-  | \$50.00   |
| m. Deck permit- standalone-   | \$25.00   |
| n. Shed /Barn/Pole Building/Pavilion-   | \$25.00   |
