ARMSTRONG COUNTY, PENNSYLVANIA IDENTIFIED AS ORDINANCE
NO. 2-89 EFFECTIVE JANUARY 1, 1990 AND AMENDED ON JUNE 8, 1994
IS FURTHER AMENDED AS FOLLOWS:


1. Article I, Section 203, Table 201, is amended to delete Agriculture as a permitted use in the "R" Residential District.
2. In all other respects the Kiskiminetas Township Zoning Ordinance, as amended, remains in full force and effect.


