- 2. Casey Bartkus (project developer from CVE Solar) with resident Frank Frickanisce
  - Provided information related to this project site and lease agreement.
  - 3-Megawatt system for 20 Acre site, public utility to Sub-station thru three phase lines
  - Discussed noise 65 dcb for 365 days, not battery storage site, security fences, barriers.
  - Asked about current zoning allowance for project. Advised by P.C. that solar does not fall under a public utility building in R-district and would need to wait for new zoning ordinance and most likely would need to get a variance for land usage change and also notify county due to clean and green status.

  - Discussion of creating new ordinance with restrictions on number of chickens based on property size and rules for coop/run and disposal.
