February 4, 2026  
Regular Meeting Minutes

Chairman Bob Ross called the meeting to order at 7:00 p.m followed by the Pledge of Allegiance.

ROLL CALL: H. Ross, B. Hilliard, A. Birch, M. Long, Solicitor Fritz, Sgt Tessmer, and Interim Twp Manager Jason Dailey. Absent was T. Tardivo

Motion by B. Hilliard seconded by A. Birch approve Minutes from the January Regular Meeting.  
Motion carried.

Motion by B. Hilliard Seconded by M. Long to approve the January Treasurers Reports. Motion carried.

Motion by B. Hilliard Seconded by M. Long approve the January Payable Voucher Lists. Motion carried.

The printed Engineering Report was provided to the Board.

There was no public comment.

## CORRESPONDENCE:

The Interim Township Manager discussed correspondence received by CNX for revised plans for road work.

## NEW BUSINESS:

Motion by B. Hilliard, Seconded by M. Long to approve the 2026 Fee Resolution. Motion carried.

Motion by B. Hilliard, Seconded by M. Long to approve the Joint Highway Occupation Permit for various intersections as a result of CNX road improvements related to the two well pads, and the subsequent maintenance agreement. Motion carried.

Motion by B. Hilliard, Seconded by A. Birch to approve the January 24, 2026 Emergency Declaration for winter weather retroactively. Motion carried.

Motion by B. Hilliard, Seconded by M. Long to approve the equipment rental of the Pug Mill from Russell Standard in the amount \$3500 per day for one day and for the cost of the oil at a cost of \$19,488 to Russell Standard for a total of \$22,988. Motion carried.

Motion by M. Long, Seconded by B. Hilliard to authorize for bid the annual chip seal program.  
Motion carried.

Motion by B. Hilliard, Seconded by H. Ross to authorize the advertising for the Amusement Tax with only the \$350 fee for electronic skill games. Motion tied with Long and Birch dissenting.

Motion by B. Hilliard, Seconded by A. Birch to table the Amusement Tax pending the outreach to the local businesses advising of the issue being revised and not including greens fees at this time. Motion carried.

Motion by A. Birch, Seconded by B. Hilliard to advertise the 2026 Revised Meeting schedule effective 2/25/26 with the Business Meeting being the Second Wednesday of the month and the Workshop meeting being the fourth Wednesday. Motion carried.
